Supported with exceptions	Altova DatabaseSpy 2019 supports a keyboard interface for input and provides fully customizable keyboard shortcuts for all menu items. The visual database table design view requires the use of a mouse or equivalent graphical input device.
(b) Applications shall not disrupt or disable activated features of other products that are identified as accessibility features, where those features are developed and documented according to industry standards. (a) At least one mode of operation and information retrieval that does not require user vision shall be provided, or support for Assistive Technology used by people who are blind or visually impaired shall be provided.	Supported with exceptions	Altova DatabaseSpy 2019 works with screen magnification, but some speech functionality does not work in Microsoft Narrator, Jaws, or ZoomText. Exceptions are documented above in 1194.21(c).
(b) At least one mode of operation and information retrieval that does not require visual acuity greater than 20/70 shall be provided in audio and enlarged print output working together or independently, or support for Assistive Technology used by people who are visually impaired shall be provided.	Supported	Altova DatabaseSpy 2019 supports the use of screen readers to access user interface information and has internal print enlarging technologies as well. Users of Windows operating systems can change the DPI settings or access Screen Magnifier in the Accessibility Options or via the Ease of Access control panel section.
